Title 12 System Updates reported by Jennifer Arroyo (Miss Utility)

- Testing continues with members confirming their ability to receive new ticket format.
- There are members who are in the process of updating their receiving software.
- SHA has stated that they will be ready to receive new ticket format prior to the 90-day window they have to complete any necessary software updates or changes.

Ticket Check, Critical Facility

- The goal of this proposal is to examine ways and to develop language whereby utility owner members can communicate via a Ticket Check code, that a proposed excavation area is in the vicinity of critical member facilities and that a standby is required on-site during excavation.
- Scott Moore, Colonial Pipeline, expressed, via virtual chat, that the Critical Facility ticket code remains on his priority list, but that he is unable to attend today's meeting. It is his plan to have something concrete (documents or PowerPoint) for the next MD/DC SUB/BOD meeting.

Jenn also shared that the call center has been made aware of a possible fraudulent ticket processor and the steps being taken to end this potentially disruptive behavior.

Susan Sullivan suggested that the BOD Tenure Log be reviewed and updated as necessary. Scott Brown recommended taking a detailed look at it during the April quarterly meeting. Susan to update information per current BOD membership prior to Board review. All were in agreement.

A short-term MD/DC Guidebook Committee is needed to review, edit, and approve an updated MD/DC Guidebook per current MD Title XII Law. Susan Sullivan, Kevin Woolbright and Jim Barron are interested in participating. Scott Brown requested that Greg Mason and Claudia Castellanos be included on any communication related to this committee.

MGH 2022 Campaign and Budget Overview



 - o There are forty-five (45) New NPVs to investigation and review.

 - o Is working on the Annual Report to the Governor,
 - Has submitted Emergency Legislation to be approved in this Legislative Session to put \$12-135 (a) (2) back into the Title XII,
 - Elected Officers for 2022; Michael Jewell Chair, Paul Kwaitkowski Vice-Chair, Tamara Neal – Treasurer and Kelly Ruddo – Secretary; and
 - Voted to renew the Authority's Government/Municipality CGA Membership for 2022.
 - The MD/DC SUB/BOD to consider a grant renewal for 2022.
