 - 105 utility damages (20 mains and 85 services)
 - 22.86% due to no call or valid ticket
 - 34.29% due to hitting a marked line
 - 21.90% due to incorrect locate marks
 - 20.95% due to other root causes

MARYLAND AUTHORITY | Jim Barron, Executive Director

- There was no meeting in February or March.
- The Authority currently has seventeen (17) NPV's to investigate and review.
- The next meeting will be a face-to-face open meeting at the Miss Utility Call Center Conference Room followed by a Closed Executive Session on April 12, 2023. The Governor's Appointment Office has advised us that the appointment of the new members will not occur in time to seat them at the April Meeting. However, the Authority is going to invite them to join both the upcoming Open Meeting and Closed Executive Session.


