Minutes of the meeting for April 25, 2023 Hybrid Meeting hosted by Miss Utility in Hanover, MD Prepared by Susan Sullivan

#### CALL TO ORDER AND INTRODUCTIONS

Chairman Kevin Woolbright called the regular monthly meeting to order at 9:32 AM. There were twenty-one (21) attendees onsite and twenty (20) virtual attendees.

# **APPROVAL OF MINUTES**

A motion to approve the March 28, 2023, minutes was made by Dominic Pope (Gaines) and seconded by George Daffan (Utiliquest). The motion carried by approval.

# **OPEN DISCUSSION**

Dominic Pope (Gaines) asked for clarification of stand-by alerts provided by BGE. He stated, for example, that one part of a recent alert (similar to a title) mentions an 8-inch facility, but a second note mentions a 24-inch facility. Marc Haines (BGE) stated that the 8-inch mention indicates that the alert goes out for all facilities 8-inches and larger (as a general alert title), but the second size listing is the actual facility size.

Shayne Boyer (P. Flanigan) asked the best course of action when an unidentified facility is exposed on a cleared ticket. Jennifer Arroyo (Miss Utility) stated that submitting discrepancies via Search and Status, for each of the listed owner members is the necessary action.

# **OLD BUSINESS**

DPC Vice Chairman

Kevin Woolbright (DPC Chairman) thanked Dominic Pope, George Daffan and Ryan Reese for their interest in the DPC Vice Chairman position. Kevin then announced George Daffan (Utiliquest) as the selected nominee for the position. He will be transitioning into the new role as Mark Hamrick, current DPC Vice Chairman leaves the position July 1.

#### **NEW BUSINESS**

Jennifer Arroyo announced the retirement of ITIC 2.0. As of June 1, 2023, ticketing access via ITIC 2.0 by way of the Legacy App, will no longer be available. The Legacy App will still be available to subscribers for access to various reporting tools.

# GUEST SPEAKER: MARY HILL | FERGUSON TRENCHING COMPANY

Mary spoke to various types of *struck-bys* contractors need to be aware of and how best to identify and avoid these types of high-risk situations. She highlighted *struck-bys* that can occur due to the falling, rolling, swinging, and the projectile of tools, materials, and equipment. She then spoke to the importance of maintaining 'situational awareness' at all times in order to avoid this potential 'line of fire.'

# MISS UTILITY CALL CENTER

Updates Reported by Jennifer Arroyo (Miss Utility)

Washington, D.C. Title 34 Law changes, affecting current ticketing, are expected to go into effect in the next 4-6 weeks. All stakeholders should be aware of the following updates to DC ticketing:

- Tickets must be submitted a minimum of 96-business hours prior to planned excavation.
- Response Due By is 72-business hours from ticket submission.
- New Start Work Date and anticipated Duration (of excavation) ticket field requirements.
- Emergency Response Due By is 72-hours from ticket submission.
- The 'remark' option will no longer be available. When marks need refreshing, an update ticket will be required with a Response Due By of 48-business hours from ticket submission.
- Mandatory positive response.
- Maryland ticketing will require a Start Work Date and Time.

Regression testing is ongoing for both MD and DC service territories. Broadcast emails will go out to all members and users about changes and implementation for both service territories.

- Dashboard Reporting: Jennifer Arroyo provided ticket volume data for the month of March 2023.
  - Inbound ticket volume: 87,010 a monthly decrease of 3.016% compared to 2022
  - Outbound volume: 458,390 a year-to-date decrease of 1.658% compared to 2022
- ➤ Damage Reporting: Susan Sullivan provided YTD data through March 2023 of reported damages in MD/DC.
  - 276 utility damages (62 mains and 214 services)
  - 26.09% due to no call or valid ticket
  - 33.33% due to hitting a marked line
  - 27.17% due to incorrect locate marks
  - 13.41% due to other root causes

# MARYLAND AUTHORITY | Jim Barron, Executive Director

- There was an Authority meeting April 12, 2023.
  - The Authority voted to resume Formal Hearings at the July 12<sup>th</sup> Meeting and approved two Formal Hearings.
  - There are currently eleven (11) NPV's to investigate and review, three (3) will be sent back for more information. Three have not yet been logged in.
  - o The Authority investigated and reviewed 4 NPV's.
  - o The Authority voted to send two warning letters.
  - o The Authority will be attending and have a booth at the MML and MACo Conferences this summer.
  - o The \$4,701.00 PHMSA Grant will be used to develop a Homeowner's Awareness Program.
  - o Susan Stroud is working on the 2022 PHMSA Evaluation which is due on May 27<sup>th</sup>.
  - o The Authority voted to donate \$6,000.00 to the Construction Angels fund to help the families of the six (6) people killed in the construction site on 695.
  - o Several Authority members will be attending the Locator Achievement Awards.
  - o The Authority gave Recognition Awards to Kelly Ruddo (One Call), Michael Jewell (subscriber) and Derek Shreves (MML) who will be leaving the Authority once the Governor Appointment Office complete the appointment of the three new members, Jennifer Arroyo (One Call), David Wilkins (Subscriber) and Michael Beall (MML).
- The next Authority meeting will be a Zoom Closed Executive Session on May 10, 2023.
