Minutes of the Committee Meeting April 13, 2023 Hosted by Miss Utility Call Center – Hanover Prepared by Secretary, Susan Sullivan

WELCOME AND INTRODUCTIONS OF ATTENDEES

The meeting was called to order by Chairman Scott Brown at 10:07 am. Customary attendee introductions were made.

A motion to approve the January 10, 2023, minutes was made by David Wilkins (WSSC) and seconded by Kevin Woolbright (DPC Chair). The motion carried by approval.

ATTENDANCE ROLL CALL

Susan Sullivan (Miss Utility) conducted a roll call of the MD/DC Board of Directors. A quorum was present. In attendance were BOD members: Scott Brown, Brian Sahm, Marc Haines, Angela Johnson, David Wilkins, Kevin Woolbright, Juan Vogel, Joe Shelton and Susan Sullivan were present. Attending members participated either in person or remotely. Mark Hamrick was unable to attend.

DPC CO-CHAIR INTRODUCTIONS

Kevin Woolbright (DPC Chairman) introduced the three (3) DPC Co-Chair nominees and gave each an opportunity to address meeting attendees. George Daffan (Utiliquest) and Ryan Reese (WGL) both spoke in person while Dominic Pope (Gaines and Company) spoke virtually. At the conclusion of this nominee introduction, Kevin noted the by-laws that allow him, as the DPC Chairman, to make the final nominee selection but that he would appreciate the feedback of Board Members before doing so. He also noted that he would make the Co-Chair announcement at the upcoming Damage Prevention Committee Meeting, April 25th.

OLD BUSINESS

Ticket Check, Critical Facility Reported by Scott Moore (Colonial Pipeline)
Scott confirmed that a second meeting will be scheduled in May to continue discussion and determine the best way to move forward with a status code all stakeholders can agree on as to a critical facility communication via Miss Utility's Ticket Check. Please consider a May 4th or May 11th meeting date.

MD/DC Guidebook Committee Reported by Susan Sullivan (Miss Utility)
The Spanish translated MD Guidebook has been forwarded to Washington Gas for their review and approval. Design and layout by MGH to follow. Once all editing is concluded, the

document will go into print production. It was also determined that the MD/DC Marking Guidelines will no longer be printed once the current allotment has been distributed. The pdf version will remain available on the Miss Utility website.

OCC User Group Video and Feedback

Board attendees provided positive feedback as to the 2022 OCC User Group Meeting held last September in Washington, D.C. Everyone agreed that the discussions surrounding shared experiences and challenges were positive as were the networking events. The event video (http://www.occugmeeting.com/) was shared as well.

 - Scott Brown shared that the conference provided great information and networking opportunities and that there were good motivational speakers that focused on personal well-being. He concluded by saying that attendance at future national conferences may have to be reduced to one a year.

Awards Criteria Update Reported by Kevin Woolbright, Awards Committee Chair Meeting highlights:

- Next year's LAA requirements will negate limitations set by having *regions*. This will allow all qualifying contract locators the ability to be nominated.
- More guests will be considered for LAA banquet attendance.
- Feedback from utility owner members and contract locators is imperative for fairly qualifying and awarding nominated locators.
- For the upcoming DSA season, 'regional' awards will be done away with as this seems to limit the number of qualified nominations, i.e., there will no longer be just a Maryland or just a D.C. winner.
- If a company is eligible, they can be awarded. This provides for more transparency and balance.
- As with the LAA, input from various stakeholders is paramount to fairly qualify and award nominees.

NEW BUSINESS

Jennifer Arroyo (Miss Utility) proposed discontinuing ITIC 2.0. After a brief discussion, Marc Haines (Board Member) made a motion to approve discontinuing ITIC 2.0 given a 30-day notice to current Legacy users. A quorum was present, and All were in favor. June 1 was agreed to as the cut-off date. Jennifer shared that in addition to a broadcast email going out, a notification pop-up would present itself to anyone clicking on the Legacy application letting them know about the discontinuance.

Jennifer also proposed that owner member ticket processors attend ITIC training prior to being given emergency ticketing access in an effort to increase ticket accuracy. Errors are being identified by iVerify, a newer OCC software platform designed to analyze the accuracy of every processed ticket. Educating emergency ticket processors on proper ITIC processing should increases ticket accuracy and therefore, worksite safety.

Jennifer reminded attendees that in addition to the afterhours phone call that can be subscribed to for emergency ticket notification there is an emergency text messaging option available as well.

Scott Brown (Board Chairman) initiated a discussion about damage notification tickets. Jennifer offered information about damage reporting practices from various OCC call centers. After some general thoughts about the proposal, Scott suggested a sub-committee be created to continue the discussion and entertain a possible pilot program. Subcommittee members to include: Scott Brown, Marc Haines, Juan Vogel, Joe Shelton, and David Wilkins. Scott recommended Kentucky call center members be invited to participate as well.

Washington, D.C. ticketing update: Regression testing is underway to ensure a smooth transition when new ticket fields go live for the Washington D.C. service territory. New fields include: a

Start Date/Time and Anticipated Duration. There will also be changes to the notification period and response due by calculations for both new and update tickets. The 15-day ticket validity period begins on the date/time of ticket submission.

The Maryland service territory will also undergo ticketing field updates. Once updates go live, Maryland tickets will have a required Start Work Date/Time field. Response due by and expiration dates will calculate based on selected Start Work Date/Time. The 12-day ticket validity period begins on the Start Work Date/Time.

MARYLAND AUTHORITY Reported by Jim Barron | Maryland Authority

- There was an Authority meeting April 12, 2023.
 - The Authority voted to resume Formal Hearings at the July 12th Meeting and approved two Formal Hearings.

- There are currently eleven (11) NPV's to investigate and review, three (3) will be sent back for more information. Three have not yet been logged in.
- o The Authority investigated and reviewed 4 NPV's.
- o The Authority voted to send two warning letters.
- The Authority will be attending and have a booth at the MML and MACo Conferences this summer.
- o The \$4,701.00 PHMSA Grant will be used to develop a Homeowner's Awareness Program.
- o Susan Stroud is working on the 2022 PHMSA Evaluation which is due on May 27th.
- The Authority voted to donate \$6,000.00 to the Construction Angels fund to help the families of the six (6) people killed in the construction site on 695.
- o Several Authority members will be attending the Locator Achievement Awards.
- o The Authority gave Recognition Awards to Kelly Ruddo (One Call), Michael Jewell (subscriber) and Derek Shreves (MML) who will be leaving the Authority once the Governor Appointment Office complete the appointment of the three new members, Jennifer Arroyo (One Call), David Wilkins (Subscriber) and Michael Beall (MML).
- The Subscriber's 2019 Grant has \$2,800 remaining in it. The Board approved a 2023 \$10,000 grant to supplement the fund.
- Jim to get approval from the MD Authority to appropriate a \$20,000 grant to the MD/DC Subscriber's Radio outreach fund.
- The next Authority meeting will be a Zoom Closed Executive Session on May 10, 2023.
