- Dashboard Reporting: Jennifer Arroyo provided ticket volume data for the month of August 2023.
 - Inbound ticket volume: 88,677 a monthly increase of 2.140 compared to 2022
 - Outbound volume: 453,529 a year-to-date decrease of 2.441% compared to 2022
- ➤ Damage Reporting: Susan Sullivan provided YTD data through August 2023 of reported damages in MD/DC.
 - 759 utility damages (188 mains and 571 services)
 - 25.82% due to no call or valid ticket
 - 34.26% due to hitting a marked line
 - 30.96% due to incorrect locate marks
 - 8.96% due to other root causes

MARYLAND AUTHORITY | Jim Barron, Executive Director | Reported by David Wilkins

- The MD Authority held a face-to-face Open Meeting followed by a closed Executive Session Wednesday, September 13, 2023.
 - Two Formal Hearings were cancelled and postponed to the December 13th meeting due to a potential legal issue on Notice.
 - o There are currently nineteen (19) NPV's to investigate and review.
 - The Authority investigated and reviewed two (2) NPV's for No Ticket Violations resulting in fines along with required Damage Prevention Training, three (3) NPV's for Marking Violations resulted in fines and a Required Policy Letter. Another was reviewed, a No Test Pit Violation, resulting in a fine along with Required Damage Prevention Training.
 - The Authority discussed a hardship request from a probable violator with a No Ticket Violation. The Authority voted to require mandatory attendance at the next in person training and then forgive the fine.
 - o The Authority recognized their three (3) outgoing members, Amber Brengel from Beltsville Supply representing PWCA, Tamara Neal from Washington Gas representing the Subscribers and Paul Kwiatkowski from Howard County representing MACo.
 - The Authority is anticipating seating the three (3) new members at the next meeting in November. They are Keith Dill from David A Bramble Contractors representing PWCA, Marc Haines from BGE representing the Subscribers and Bahreh Inanloo from Montgomery County DPW representing MACo.
- The next meeting will be an Open Meeting followed by a Closed Executive Session on November 8, 2023. There is no meeting in October due to a conflict with the Maryland Subscriber's Meeting


