Minutes of the Committee Meeting October 11, 2023 Hosted by Miss Utility – Wisp Resort Prepared by Secretary, Susan Sullivan

WELCOME AND INTRODUCTIONS OF ATTENDEES

The meeting was called to order by Board Member David Wilkins at 10:06 am. Customary attendee introductions were made. A motion to approve the July 13, 2023, minutes was made by Kevin Woolbright (DPC Chairman) and seconded by Angela Johnson (AT&T). The motion carried by approval.

ATTENDANCE ROLL CALL

Susan Sullivan (Miss Utility) conducted a roll call of the MD/DC Board of Directors. A quorum was present. In attendance were BOD members: Scott Brown (virtual), Marc Haines, Angela Johnson, David Wilkins, Kevin Woolbright, Juan Vogel, Joe Shelton, George Daffan and Susan Sullivan.

OLD BUSINESS

Damage Tickets | Scott Brown, Board Chairman

Scott opened up the discussion by asking board members to provide initial thoughts about creating an optional damage ticket header. Comments included:

- Additional damage ticket transmission charges would be absorbed by owner members.
- Damage reporting is already mandatory for gas utility damages or damages with costs of \$3,000 or greater.
- Optional damage reporting may not garner desired results, especially if not legislated and enforceable.
- Would damage reporting include abandoned lines? This might skew data.
- Excavators may fear that optional damage reporting would make them 'look' bad if information was shared publicly.
- Damage reporting could be used to target areas for damage prevention advertising, education and outreach.
- Provide general awareness for utility owner members.

After a thorough discussion of additional pros and cons, board members decided to table any movement forward at this time.

Ticket Check, Critical Facility Update | Jennifer Arroyo, Miss Utility Development of the critical facility code is underway.

MD/DC Guidebook Committee | Susan Sullivan, Miss Utility The Maryland Damage Prevention Guide is currently available online at <u>https://www.missutility.net/resources/</u> in PDF. A second order of 2,000 copies has been ordered.

Online Damage Prevention Training Module Update | Kevin Woolbright, Chairman The subcommittee has completed its review of two (2) modules. The next meeting is scheduled for Tuesday, October 17th where additional modules will be reviewed. There are six (6) total.

NEW BUSINESS

Online Dashboards | Jennifer Arroyo

Jennifer shared real time dashboard data from NewYork811(<u>https://newyork-811.com/</u>) to illustrate the latest in OCC's public facing data sharing products. It was noted that information refreshes regularly throughout the day, the type of data shared is determined by utility stakeholders, and that date range options can vary. Noted benefits: utility owner members can note, in real time, where excavation is taking place regionally, excavators can determine the best start dates based on ticket volume and response due by dates, contract locators can forecast high volume demands/trends and plan ahead. The Board agreed unanimously to have the initial dashboard set up with possible enhancements to be discussed at a later date.

ITICnxt: Radius Tool Functions | Jennifer Arroyo

The radius tool currently pulls in parcel data when any part of the circle touches a parceled property. This can cause confusion to a locator who may look for the polygon's center point on the given property but does not exist. An updated radius tool would only pull in parcel data if the center point was located within the given parcel. Otherwise, when the center point is located outside of a given parcel, in an intersection, right of way or roadway for example, the address field on the ticket would remain blank which is standard practice when a polygon falls outside of a boundaried parcel. Board members agreed to replace the current radius tool guidelines with the updated guidelines as discussed.

MD/DC By-Law Update and Approval | Susan Sullivan

A proposal to update noted nomination, voting and seating months was proposed and approved by Board Members and are as follows:

- Voting to take place in January versus April
- Seating to take place in April

An email was sent out September 18th to all subscribers on file and an announcement made during the September 19th Damage Prevention Committee Meeting indicating that interested parties should send in eligible nominations along with a brief bio to Susan Sullivan, no later than

October 6th. Declarations of interest to continue in their current Board Member seats for another term of three (3) years were Marc Haines, Angela Johnson and Joe Shelton. Two additional nominations were received for the Communications Seat: Patrick Wiltshire of Shentel/Glofiber and Felix Dialoiso of Harbor Link Inc. An additional nomination was received for the Government Seat from Pieter Aarsbergen of Howard County. All nominations will be considered and voted on during the first quarter Sub/BOD Meeting in January 2024. Selected nominees will be notified soon after with seating to take place in April of 2024.

The BOD Vice Chair seat has recently been vacated. Interested Board Members should email Scott Brown, Chairman, a notice of interest no later than October 13th. Voting to take place in January 2024.

OCC User Group Feedback

- Radio targeted Spanish-speaking excavators and homeowners with translated ads airing on two D.C. stations (one of which is simulcast in Baltimore).

 - In June 2023, MGH and Miss Utility launched a number of Meta (Facebook/Instagram) ad campaigns, aimed at raising awareness of 811 messaging among English- and Spanish-speaking contractors.

 - TV and radio stations promoted 8/11 Day, Miss Utility, and the importance of calling 811 on-air and on their social pages.



One Call Concepts, 2023 Creative Team Report 2nd Quarter details were reviewed with a total of 388:07:30 service hours being logged for the year.

The committee reviewed the Schedule of Advertising report and budgetary items.

MARYLAND AUTHORITY | Jim Barron (Executive Director)

- There was no meeting in October as it conflicted with the 10/11/23 Subscriber/BOD Meeting. The Third Quarterly Authority Meeting in person was held on 09/13/23. The Authority seated four (4) Authority Members whose seats expired on 09/30/22. Those members seated were:
 - David Gaines (Gaines & Co) 2nd 2-Year Term, the AUC of MD seat,
 - o David Wilkins (WSSC) in the Subscriber's Seat replacing Michael Jewell,
 - o Jennifer Arroyo (OCC Inc) in the One Call Seat replacing Kelly Ruddo, and
 - Michael Beall (DPW Director, University Park) in the MML seat replacing Derek Shreves.

- There were also five (5) Authority Terms that expired on 9/30/23. The Authority is waiting on those Appointments by the Governor. They are:
 - Amber Brengel (Beltsville Supply) to be replaced by Keith Dill (David A Bramble), PWCA Seat
 - James Dudley (Public Member), 2nd 2-Year Term
 - Paul Kwiatkowski (Howard County) to be replaced by Bahareh Inanloo (Mont Co DPW), MACO Seat
 - o James Jennings (OCCLS), 2nd 2-Year Term, Locator Seat
 - Tamara Neal (Wash Gas) to be replaced by Marc Haines, Subscriber's Seat.
- The Authority currently has twenty-five (25) NPV's to investigate and review:
 - 11 Marking, 10 No Ticket, 1 Repeat Notification, 2 Due Care, and 1 No Test Pit. All twenty-five to be adjudicated under the Post 06/01/22 Statute.
- The Authority tentatively (depending on new members to be seated on 11/8/23) voted to hold two (2) Formal Hearings on 12/13/23. That final decision will be made at the November 8th meeting.
- The Authority reviewed two (2) No Ticket Violations; One (1) Failure to create a "Documented Agreement" following a Code 7; Two (2) Marking Violations; One (1) No Test Pit Violation.
- The Authority reviewed a 'hardship' request to reduce a fine for a previous No Ticket Violation. The Authority voted to tell the violator if he takes the Damage Prevention Training on November 3rd the Authority will eliminate the fine. If he doesn't take the training, the fine stands.
- The Subscriber's 2023 Grant has \$12,400 remaining in it.
- The Authority is asking the Subscriber's to approve another \$0.05 per outgoing ticket at this meeting so the Authority can draft legislation to be presented at the 2024 Legislative Session.

The next Authority meeting will be an Open Meeting with a Closed Executive Session on November 8, 2023.

TITLE-12 RE-WRITE

The Authority plans to go to the Legislature in 2024 to change the date when Authority Members' terms expire from September 30th to April 30th. The Authority also plans to include the addition of \$0.05 per outgoing tickets in legislation if approved by the Subscriber's.
