Minutes of the meeting for January 23, 2024 Hybrid Meeting hosted by Miss Utility in Hanover, MD Prepared by Susan Sullivan

## CALL TO ORDER AND INTRODUCTIONS

Chairman Kevin Woolbright called the regular monthly meeting to order at 9:34 AM. There were thirty-six (36) attendees onsite and twenty-five (25) virtual attendees.

## APPROVAL OF MINUTES

A motion to approve the November 28, 2023, minutes was made by Michael Jewell (Columbia Gas) and seconded by Shelly Masone (Ecotech). The motion carried by approval.

#### **OPEN DISCUSSION**

A question from Kris Dietrich (New Direction Utilities) ascertained whether locators have access to a ticket's polygon. Jennifer Arroyo (Miss Utility) answered that every ticket, once released, includes the mapping. However, whether the mapping is received by the owner member or its contract locator depends on their receiving software. It was also noted that the user created polygon is for member notification. Although it can be used as an additional tool by a locator, it is the Extent of Work field that is used for marking purposes. Kris also brought up and asked questions about a recent damage his company incurred. Multiple attendees provided information and feedback.

Sean Paris (Ft. Meyer) inquired about D.C. Verizon locates as his tickets are currently not being statused. David Knox (Utiliquest) shared that starting Wednesday, January 24, 2024, at 7:00AM, Utiliquest would be taking over D.C. Verizon locates. David and Daniel Blais provided their contact information in the meeting chat.

Sean followed up by asking why Emergency Ticket Response Due By dates are the same as a Standard Ticket's RDB dates. Jennifer referenced the emergency exception clauses, found in both Title 12 and 34, thereby requiring the same RDB dates as a Standard Ticket. See law references below.

#### MD: §12–121 (c) (1).

The owner–member or its contract locator shall:

- (i) respond to an emergency notice as soon as possible but not later than 2 hours from the transmission of the ticket from the one–call system; and
- (ii) except for circumstances beyond an owner–member's or contract locator's control and for municipal corporations, considering the hours of operation and availability of employees:
- 1. begin the locating process to mark their respective underground facility or facilities within 3 hours after the transmission of the ticket; or
- 2. if the facility owner has no underground facilities within the delineated excavation area, clear the ticket within 3 hours after the transmission of the ticket.

## DC: § 34–2709. Emergency excavation or demolition.

Compliance with the notice requirements of § 34-2704 shall not be required for an emergency excavation or demolition involving an imminent danger to life, health, or property; provided, that reasonable precautions have been taken to protect underground facilities. The appropriate utility operators shall, in any event, be notified directly and as soon as possible. The appropriate utility operator shall respond by marking the approximate horizontal location of the underground facility within 2 hours of notification of the emergency excavation or demolition, where practicable. An imminent danger to life, health, or property exists whenever there is a substantial likelihood that loss of life, health, or property will result before the procedures under § 34-2704 can be fully complied with.

Joe Shelton (BF Joy) thanked Utiliquest for its quick decision in taking over the D.C. Verizon locate contract.

Wen Liang (Anchor) highlighted the negative impact it has on contractors when contract locate companies abruptly cease locating and asked if there was a way to communicate with contractors when contract locate companies are in transition. Kevin Woolbright (DPC Chairman) replied that owner members are not required and generally do not communicate this type of information.

Ian Jones (BGE) is transitioning out of his current position. His replacement to be announced in the next few weeks. Please reach out to Marc Haines in the meantime.

Philip Dethlefs (Shentel Glo Fiber) initiated a discussion on virtual white lining. Various input was shared by attendees. Jennifer Arroyo stated that virtual white lining still limits what can be received by some vendors. Scott Brown (WGL) acknowledged that there is a national discussion on virtual white lining and its potential benefits. He briefly shared examples of what other states are doing and that although not perfect, MD and VA are progressively encouraging virtual white lining at the legislative level.

## **OLD BUSINESS**

No old business to report.

#### **NEW BUSINESS**

Jennifer Arroyo (Miss Utility) introduced the Miss Utility Online Dashboards and shared a preview. Although not yet available, she explained that this new tool may assist contractors with selecting start work dates that show lower ticket volume and/or Response Due By Date volume. Although created to aid utility owner members and subscribers, the availability for contractors to view real time ticket volume may result in the normalization of locator ticket volume by reducing spikes in demand that often occurs when the volume of incoming tickets is at its greatest.

## **GUEST SPEAKERS: Courtney Tolson | SAM Companies**

Courtney Tolson, Project Manager for MD/VA introduced himself and shared his presentation titled: SAM Services & the Importance of Damage Prevention and Underground Utility Mapping. SAM Companies provides professional underground utility mapping services that include Subsurface Utility Engineering (SUE), GPS and 3D Mapping. Other Damage Prevention Services include: Inventory Recording of both legacy and capital facilities, untoneable facility repair, ticket risk field response and standby services. He stressed the value their specialized capabilities and services have on reducing the risks associated with various types of excavation activities including those involving natural gas, electric, telecommunications and transportation, as well as state, municipal, federal, and publicly funded projects.

  - Inbound ticket volume: 66,076 a monthly increase of 3.898% compared to 2022
  - Outbound volume: 345,447 a year-to-date decrease of 3.437% compared to 2022
- ➤ Damage Reporting: Susan Sullivan provided YTD data through December 2023 of reported damages in MD/DC.
  - 1,212 utility damages (288 mains and 924 services)
  - 24.09% due to no call or valid ticket
  - 33.00% due to hitting a marked line
  - 33.09% due to incorrect locate marks
  - 9.82% due to other root causes

#### MARYLAND AUTHORITY | Jim Barron, Executive Director |

- The Authority held an Open Meeting and Closed Executive Session on December 13, 2023. The Authority:
  - Reviewed 3<sup>rd</sup> Quarter Financials.
  - o Held an Authority Member Orientation since there are several new members.

- Postponed the NPV's scheduled for review in Closed Executive Session to the January 10<sup>th</sup> meeting due to the lateness of the Closed Executive Session.
- The Authority held an Open Meeting and Closed Executive Session on January 10, 2024.
  - o Because only six (6) members attended the meeting, members voted to postpone the election of officers to the February 14<sup>th</sup> meeting.
  - There was a review of 4th Quarter Financials.
  - o Formal Hearings scheduled for February were rescheduled for the March 13<sup>th</sup> meeting at the request of the Probable Violators.
  - o The Authority currently has twenty (20) NPV's to investigate and review.
  - The Authority renewed its CGA Membership and added James Dudley and Keith Dill in place of previous members, Amber Brengel, and Kelly Ruddo to the active membership list.
  - o In Closed Executive Session the Authority postponed one NPV because two (2) Authority Members (the complainant and the probable violator) would have to recuse themselves leaving the Authority short of a quorum.
  - The Authority reviewed one (1) NPV for a Marking Violation and three (3) for No Ticket 1<sup>st</sup> Offense Violations.
  - The Authority voted to send a Warning Letter to Top Property Flippers, LLC for allegedly working in the City of Havre de Grace without a Miss Utility Ticket.
- The Authority's lobbyist is receiving push back on the proposal to raise the \$0.05 per out going ticket to \$0.10 per out going ticket. It was decided to not drop the legislation this year and do it next year. That includes the legislation to change the end date of Authority Member Terms. The Authority will begin to work the legislation by having meetings with the major facility owners and legislators starting in September 2024.
- The next meeting will be an Open Meeting with a Closed Executive Session on February 14, 2024.

#### Title-12 Re-Write:

The Authority plans to drop legislation in 2025 to change the date when Authority Member's Terms expire from September 30th to April 30th and for the addition of \$0.05 per outgoing tickets.


