Miss Utility offers a variety of training opportunities that include Onsite, Open and Virtual Training platforms.

- **Onsite DP Training (English and Spanish) at your Worksite Location:** The Damage Prevention Training team will come to your place of business in Western Shore Maryland or Washington DC to provide **FREE** Miss Utility/811 Damage Prevention Training for a **guaranteed 10 (or more) attendees**.
  - Please allow a 4-week minimum between request and confirmed training date. We do ask that free parking be made available to our training team members in advance.
  - The onsite training team can be made up of utility owner-members who provide utility services in your work territory (when available) in addition to Miss Utility's Damage Prevention Liaison. The teams are typically two to five training experts depending on the time allotted for training. Training can be presented in **English and/or Spanish**, depending on Spanish trainer availability.
